




 Project Area



The Native American Heritage Commission was able to perform a record search of its Sacred Lands File (SLF) for the affected project area/area of potential effect (APE). The SLF failed to indicate the presence of Native American cultural resources in the immediate project area. The absence of specific site information in the Sacred Lands File does not guarantee the absence of cultural resources in any project area. This project site is in close proximity to previously discovered prehistoric burial sites and is believed to hold numerous cultural resources.

Early consultation with Native American tribes in your area is the best way to avoid unanticipated discoveries once a project is underway. Enclosed is the name of the nearest tribes that may have knowledge of cultural resources in the project area. A list of Native American contacts is attached to assist you. It is advisable to contact the persons listed; if they cannot supply you with specific information about the impact on cultural resources, they may be able to refer you to another tribe or person knowledgeable of the cultural resources in or near the affected project area. A local tribe may be the only source of a Native American cultural resource.

Lack of surface evidence of archeological resources does not preclude the existence of archeological resources. Lead agencies should consider avoidance, as defined in Section 15370 of the California Environmental Quality Act (CEQA) when significant cultural resources could be affected by a project. Also, Public Resources Code Section 15064.5(f) and Section 15097.98 and Health & Safety Code Section 7050.5 provide for provisions for accidentally discovered archeological resources during construction and mandate the processes to be followed in the event of an accidental discovery of any human remains in a project location other than a 'dedicated cemetery. Discussion of these should be included in your environmental documents, as appropriate.



The alternatives being considered include: (1) Alternative 1: No Build – proposing that no improvements be implemented at this time; (2) Alternative 2: Widen I-10 to accommodate an HOV lane in each direction with a standard 10-foot inside shoulder and a 3-foot HOV lane buffer; and (3) Alternative 3: Widen I-10 to accommodate an HOV lane in each direction with a non-standard inside shoulder and lane buffers widths at some locations to avoid impacts to existing roadway features and sensitive environmental resources. The proposed project would encourage ridesharing and are expected to reduce congestion and improve the overall operational efficiency of the I-10.

In addition to the proposed roadway improvements, approximately 20 proposed Construction Staging Areas (CSAs) have been included in the overall project Area of Potential Effect (APE) which may be used for project-related construction activities. As would be expected, areas within the project footprint along the I-10 have been extensively disturbed during the construction and subsequent maintenance of the freeway. Therefore, the cultural resources surveys will be focused on the proposed CSAs.

The cultural resources studies to be completed as part of the proposed project include cultural resources investigations and consultation with interested parties. To date, the cultural resources literature and records search for a one-mile radius of the project APE, conducted at the San Bernardino Archaeological Information Center at the San Bernardino County Museum, indicate that one prehistoric archaeological site, 16 historical archaeological sites, 96 historical structures, and one historical district have been recorded previously. Poorly recorded in 1938, the prehistoric site (CA-SBR-3000) reportedly contained a mortar and pestle located on a knoll in the Santa Ana River; the record also states that the "site appears to having been destroyed by construction and farming." Although CA-SBR-3000 was very poorly mapped, it appears that the site was located approximately 500 feet from the project APE. Of the historical archaeological sites, several historical roads, canals, and railroads, as well as the historical Kaiser Steel Mill, crossed the project APE but have long been destroyed during the historical development of the area. The closest historical resource to the project APE is the Southern Pacific Railroad – this resource is currently in use and will not be affected by the proposed project.

The archaeological pedestrian survey of the project APE will be completed in fall of 2008 once the Rights-of-Entry parcels within the CSAs have been obtained.

SANBAG and Caltrans are interested in receiving input from the local Native American community regarding any concerns related to the proposed project. The Native American Heritage Commission has been contacted and a search was performed within their Sacred Lands File. This search failed to indicate the presence of Native American cultural resources in the immediate project area. However, please inform us of any areas of cultural significance that we should take into account for the purpose of this project. This letter will be followed shortly with a telephone call to discuss any issues and/or comments that you may have.



On behalf of the Federal Highway Administration (FHWA), the California Department of Transportation (Caltrans), in conjunction with San Bernardino Associated Governments (SANBAG), proposes to improve the Interstate 10 (I-10) corridor. The proposed I-10 Corridor Project (Project) consists of adding lane(s) and providing improvements along all or a portion of the existing 33-mile stretch of I-10 from approximately 2 miles west of the Los Angeles/San Bernardino County line in the City of Pomona to Ford Street in the City of Redlands (see attached map). The I-10 Corridor Project (EA 0C250) considers one “no build” alternative, and two “build” alternatives to address existing and future projected traffic demands.

As originally proposed, two alternatives were considered for the Project: Alternative 1 (No Build) and Alternative 2 (One High Occupancy Vehicle Lane in Each Direction). Alternative 2 would extend the existing High Occupancy Vehicle (HOV) lane in each direction of I-10 from the current HOV terminus near Haven Avenue in the City of Ontario to Ford Street in the City of Redlands, a distance of approximately 25 miles. A cultural resources technical study of the original Area of Potential Effect (APE) associated with the Project was completed in 2008 by Applied Earthworks (Æ). As part of this work, Æ requested a Sacred Lands File search from the Native American Heritage Commission (NAHC). The search failed to identify the presence of any Native American cultural resources within the Project area or within a half-mile search radius. The NAHC provided Æ with a list of eight Native American individuals and associated organizations to be contacted. Æ subsequently sent scoping letters to these individuals and groups requesting input on Native American cultural resources that may be present in the Project. Several responses were received as a result of these scoping efforts including two requests to be notified if prehistoric/ethnohistoric resources were discovered during ground-disturbing activities and a request for a copy of the finalized cultural resources report.

The pedestrian survey that was conducted in 2008 identified two historical archaeological sites within the Project APE: the Mill Creek *Zanja* (CA-SBR-8092H) and an early 20th century homestead/farmstead site (CA-SBR-12989H). No prehistoric archaeological resources were identified as a result of the field survey. The Mill Creek *Zanja* consists of a linear canal structure which begins at the Mill Creek, traverses the city of Redlands, and ends near the Asistencia in the Mission District of Loma Linda. The Mill Creek *Zanja* was constructed in 1819 by Native Americans associated with the Asistencia, and the water was brought in to irrigate crops. The Mill Creek *Zanja* was previously listed in the NRHP, was designated California Historical Landmark No. 43, and was designated Engineering Landmark No. 21 by the Los Angeles Section of the American Society of Civil Engineers. The sides of the portion of the original *Zanja* located within the Project APE appear to be buried under 3 to 4 feet of imported fill; the interior of the original feature has been scoured out with heavy machinery over the years.

Recently, the proposed Project has been expanded to include consideration of a third alternative (Two Express Lanes in Each Direction). Alternative 3 would provide two Express Lanes in each direction of I-10 from the Los Angeles/San Bernardino County Line to California Street (near State Route 210) in the City of Redlands and one Express Lane in each direction from California Street to Ford Street in the City of Redlands, a total of 33 miles.

West of Haven Avenue, a single new lane would be constructed and combined with the existing HOV lane to provide two Express Lanes in each direction; east of Haven Avenue all Express Lanes would be constructed by the Project.

The addition of Alternative 3 has resulted in the expansion of the original APE and the need for revisions to the cultural resources technical report and supplemental Native American coordination efforts. Therefore, an updated records search of the revised APE was conducted at the California Historical Resources Information System (CHRIS) with a updated Sacred Lands File also requested from the NAHC. The findings of these records searches indicate that no previously identified prehistoric cultural resources or Native American cultural resources are located within the expanded portion of the proposed Project APE. Pedestrian surveys of the newly added portions of the APE are expected to be conducted in the upcoming months.






Figure 2: Project Location Map




Figure 2: Project Location Map



The Soboba Band of Luiseño Indians appreciates your observance of Tribal Cultural Resources and their preservation in your project. The information provided to us on said project has been assessed through our Cultural Resource Department, where it was concluded that although it is outside the existing reservation, the project area does fall within the bounds of our Tribal Traditional Use Areas. This project location is in close proximity to known village sites and is a shared use area that was used in ongoing trade between the bands. The Soboba Band considers the project area to be extremely sensitive for Native American cultural sites and is concerned about Native American cultural resources that may be affected by this project.

The Soboba Band of Luiseño Indians is requesting the following:

1. To initiate government-to-government consultation with the Federal Highway Administration and Caltrans in accordance with Section 106.
2. Soboba Band of Luiseño Indians continues to act as a consulting tribal entity for this project. The transfer of information to the Soboba Band of Luiseño Indians regarding the progress of this project should be done as soon as new developments occur.
3. Working in and around traditional use areas intensifies the possibility of encountering cultural resources during the construction/excavation phase. The Soboba Band of Luiseño Indians requests that a Native American monitoring component be included as a mitigation measure for this project, with Native American Monitor(s) from the Soboba Band of Luiseño Indians Cultural Resource Department to be present during **ground disturbing activities**. This includes but is not limited to **any future surveys** and **archaeological testing**, and **site clearing**.
4. Request that proper procedures be taken and requests of the tribe be honored (see attachment)

Cultural Items (Artifacts). Ceremonial items and items of cultural patrimony reflect traditional religious beliefs and practices of the Soboba Band. The Developer should agree to return all Native American ceremonial items and items of cultural patrimony that may be found on the project site to the Soboba Band for appropriate treatment. In addition, the Soboba Band requests the return of all other cultural items (artifacts) that are recovered during the course of archaeological investigations. When appropriate and agreed upon in advance, the Developer's archeologist may conduct analyses of certain artifact classes if required by CEQA, Section 106 of NHPA, the mitigation measures or conditions of approval for the Project. This may include but is not limited or restricted to include shell, bone, ceramic, stone or other artifacts.

The Developer should waive any and all claims to ownership of Native American ceremonial and cultural artifacts that may be found on the Project site. Upon completion of authorized and mandatory archeological analysis, the Developer should return said artifacts to the Soboba Band within a reasonable time period agreed to by the Parties and not to exceed (30) days from the initial recovery of the items.

Treatment and Disposition of Remains.

- A. The Soboba Band shall be allowed, under California Public Resources Code § 5097.98 (a), to (1) inspect the site of the discovery and (2) make determinations as to how the human remains and grave goods shall be treated and disposed of with appropriate dignity.
- B. The Soboba Band, as MLD, shall complete its inspection within twenty-four (24) hours of receiving notification from either the Developer or the NAHC, as required by California Public Resources Code § 5097.98 (a). The Parties agree to discuss in good faith what constitutes "appropriate dignity" as that term is used in the applicable statutes.
- C. Reburial of human remains shall be accomplished in compliance with the California Public Resources Code § 5097.98 (a) and (b). The Soboba Band, as the MLD in consultation with the Developer, shall make the final discretionary determination regarding the appropriate disposition and treatment of human remains.
- D. All parties are aware that the Soboba Band may wish to rebury the human remains and associated ceremonial and cultural items (artifacts) on or near, the site of their discovery, in an area that shall not be subject to future subsurface disturbances. The Developer should accommodate on-site reburial in a location mutually agreed upon by the Parties.
- E. The term "human remains" encompasses more than human bones because the Soboba Band's traditions periodically necessitated the ceremonial burning of human remains. Grave goods are those artifacts associated with any human remains. These items, and other funerary remnants and their ashes are to be treated in the same manner as human bone fragments or bones that remain intact.

Coordination with County Coroner's Office. The Lead Agencies and the Developer should immediately contact both the Coroner and the Soboba Band in the event that any human remains are discovered during implementation of the Project. If the Coroner recognizes the human remains to be those of a Native American, or has reason to believe that they are those of a Native American, the Coroner shall ensure that notification is provided to the NAHC within twenty-four (24) hours of the determination, as required by California Health and Safety Code § 7050.5 (c).

Non-Disclosure of Location Reburials. It is understood by all parties that unless otherwise required by law, the site of any reburial of Native American human remains or cultural artifacts shall not be disclosed and shall not be governed by public disclosure requirements of the California Public Records Act. The Coroner, parties, and Lead Agencies, will be asked to withhold public disclosure information related to such reburial, pursuant to the specific exemption set forth in California Government Code § 6254 (r). Ceremonial items and items of cultural patrimony reflect traditional religious beliefs and practices of the Soboba Band. The Developer agrees to return all Native American ceremonial items and items of cultural patrimony that may be found on the project site to the Soboba Band for appropriate treatment. In addition, the Soboba Band requests the return of all other cultural items (artifacts) that are recovered during the course of archaeological investigations. Where appropriate and agreed upon in advance, Developer's archeologist may conduct analyses of certain artifact classes if required by CEQA, Section 106 of NHPA, the mitigation measures or conditions of approval for the Project. Ms. Brierty returned my call. She noted that the Tribe had concerns regarding Native American cultural resources in the following two areas:


- 1) The portion of the I-10 Corridor situated between San Timoteo Wash east to approximately Nevada Street. The area south of this portion of the corridor contains the Mission Zanja and the San Bernardino Asistencia. In addition, a mission-era habitation site has also been recorded along Mission Road to the east of Mountain View Avenue (where Mission Road and a transmission line intersect). Ms. Brierty noted that this was an Indian Rancheria known as *Guachama*. The settlement was established by Cahuilla and Serrano groups who had been brought to the area by the Spanish to work in the citrus orchards associated with the asistencia. Ms. Brierty also mentioned that human remains have been found in the vicinity of this site.
- 2) The area along the eastern end of the Project along Reservoir Canyon in the City of Redlands. Ms. Brierty noted that the Crystal Springs site is located just south of I-10 in the vicinity of Wabash Avenue. She stated that this site was near a natural spring and that it had contained a prehistoric village site. She mentioned that the spring had been used during the historic period by a water bottling company.

Ms. Brierty stated that because of the cultural sensitivity of these two areas, she would like a Native American monitor present during ground-disturbing activities in these portions of the Corridor.

Although she was not aware of any other Native American sites along the Project corridor, she requested that the Tribe be contacted if there were any inadvertent discoveries (prehistoric, ethnohistoric, and possibly historic) during construction.

She also requested the San Manual be given copies of all of the environmental documents (including appendices), cultural resources technical reports, and maps once these documents had been finalized.

Finally, she requested that Caltrans initiate government-to-government consultation with San Manual Band of Mission Indians.






Figure 2: Project Location Map





Figure 2: Project Location Map





Figure 2: Project Location Map





Figure 2: Project Location Map

Thank you for the opportunity to offer comments and concerns regarding cultural resources in the project area of the I-10 Corridor Project that is proposed by San Bernardino County Association of Governments (SANBAG), Caltrans, and the Federal Highway Administration (FHWA).

As shown in the preliminary plans that were provided at the meeting held at the City of Upland Public Works Department on May 6, 2014, the Euclid overpass at the I-10 and some of the associated ramps may need to be demolished and reconfigured. As discussed at the meeting, you are seeking preliminary comments in order to refine the project design and assess the potential impacts as they relate specifically to Euclid Avenue. As such, the Development Services Department and Public Works Department offer the following comments:

- Within the City of Upland's boundaries, Euclid Avenue is a tree-lined, four-lane divided highway with an average width of 200 feet that extends from the northern to the southern City boundaries. Because of its association with the Chaffey brothers, the Ontario Model Colony, age (established 1882), and design and visual interest, Euclid Avenue is considered a local, State, and nationally recognized cultural resource. In addition, the City has designated Euclid Avenue as a scenic resource and has established the Euclid Avenue Scenic Overlay Zone, which pertains to the area within 250 feet of the center line of Euclid Avenue between the north and south city limits.
- Although the existing bridge structure has been modified, the width of the Euclid Avenue median is considered a character-defining feature. Any potential reduction to the existing width of the median should be evaluated as a potentially significant impact.
- Rock curbs are considered cultural and aesthetic resources within the City of Upland and are a character-defining feature all along Euclid Avenue. The project design should incorporate the replacement of rock curbs.
- In the event that the bridge must be reconstructed, the City recommends that the design team explore the feasibility of adding parkway area and landscaping similar to the bridge structure over the I-210.



- In the event that the bridge and/or median must be modified and/or reconstructed, the City believes there is an opportunity to incorporate new landscaping and hardscape elements that would reflect the City's agricultural past, such as the following:
 - Use of citrus and smaller decorative trees in an "allee" that replicates the tree pattern on Euclid Avenue.
 - Use of rock cobble in the median and on and off-ramps where paving is desired (other than pedestrian pathways).
 - Use of lighting standards that match the historic twin nostalgic lighting along Euclid Avenue.
 - Use of a decorative bridge design that reflects the history of Euclid Avenue or creates a sense of history that is appropriate for the project.
 - Use of fencing on the bridge that complements the project design.
- Given the preliminary location for the west-bound on-ramp to the I-10 Freeway, it appears there will be an increase in traffic volume on east-bound 7th Street in the City of Upland. This potential increase should be studied in the environmental analysis. In addition, this increase in traffic volume will originate outside of the City of Upland. This volume increase will create additional unfunded roadway maintenance requirements on the part of the City of Upland. This obligation should be evaluated in the environmental documentation and discussed with the City of Upland.
- Given the preliminary location for the west-bound on-ramp to the I-10 Freeway and the potential vacation of State property (i.e., cloverleaf on-ramp) and the potential for development of the site, future access and potential signal requirements to the site from both eastbound and westbound 7th Street and northbound Euclid Avenue should be studied in the environmental document and incorporated into the project design.
- The City supports facilitating bicycle and pedestrian circulation across the bridge. Decorative paving should be considered for crosswalks and possible bicycle lanes for emphasis and aesthetics.
- We understand and support the preparation of an Environmental Impact Statement and Environmental Impact Report in accordance with federal and State requirements.
- Although a number of preliminary design options were provided for review, the City would like more detailed information regarding the project prior to selecting a preferred alternative or option. In addition, the City would like to participate in the design process for the bridge in conjunction with the City of Ontario.

Thank you for the opportunity to comment on the I-10 Corridor Project- Euclid Avenue Interchange and Bridge proposed by San Bernardino County Association of Governments (SANBAG) in cooperation with Caltrans and the FWHA.

Historic and Cultural Landscape Significance

In 2005, the Euclid Avenue Right-of-way, including the median, from 24th Street in Upland to Philadelphia Street in Ontario, was listed on the National Register of Historic Places as a historic district. In 2013, the Ontario City Council designated the Euclid Avenue neighborhood, located north of G Street and south of the I-10, a local historic district. The local historic district includes all properties which have frontage along Euclid Avenue and the median, including the right-of-way. Euclid Avenue is also identified as a significant Cultural Landscape. Designed and laid out in 1882 by George and William Chaffey, town founders, Euclid Avenue is considered to be the "backbone" and the centerpiece of the development of the Original Model Irrigation Colony, which includes the Cities of Ontario and Upland.

Character-defining Features of Euclid Avenue and the median include the 60' wide landscaped median, 15' wide landscaped parkways, King Standard Lamppost, scored sidewalks, and rock curbs along the median and street edges. Currently there are more than three dozen tree varieties planted in the median and along the parkway. The most prominent trees are California Peppers, Silk Oak, Coast Live Oak, Deodar, and Camphor. Euclid Avenue was first planted in 1883 with a double row of California Pepper trees fifty-feet on center along with Palms. Based on historic

photographs, Palms appear to have been planted at prominent intersections and activity nodes. Eucalyptus and Silk Oaks were also planted in the parkways.

Historic Euclid Avenue has a moderate to high level of integrity as it continues to convey its cultural significance and serves as an outdoor public space. Over the years, inappropriate alterations to Character-defining Features have occurred within the Euclid Avenue right-of-way such as the removal of rock curb, and the installation of inappropriate trees and light standards. Character-defining Features should be restored where possible. As Euclid Avenue bridge construction and reconstruction occurs, incompatible alterations should be removed and Character-defining Features should be restored.

As shown on the preliminary plan provided, the City of Ontario Planning Department offers the following comments for the Euclid Avenue Interchange and Bridge. Prior to selection of the final project interchange and bridge alternative, we request notification and an opportunity to provide additional comments. In addition, we would like to participate in the design process of the bridge.

Planning Department

Euclid Avenue Bridge

- Median should be landscaped in a manner which is consistent and compatible with the existing historically significant median landscape design north and south of the bridge. New tree planting on the bridge shall be similar in appearance to the existing median tree, California Pepper *Schinus molle*, but with smaller size and weight for use in the shallow planters such as Willow Pittosporum *Pittosporum phillyraeoides*, 36" box size. They should be arranged in double rows equally spaced along the median. The existing palms shall be relocated to another site. Incorporate new raised planters for the tree planting similar to the low stone walls found on historic homes along Euclid Avenue and underplant trees with flowering groundcovers such as Rock Rose or Verbena. A low water using groundcover such as California native San Diego Bent Grass *Agrostis pallens*, sod shall be used to reflect the appearance of lawn with less water and maintenance. Irrigation shall be highly efficient and appropriate for plant needs.
- Landscaped parkways should be installed and planted with a small evergreen narrow tree such as Water Gum, *Tristania laurina*, 24" box spaced 20' apart to separate pedestrians from traffic, while providing some shade and visibility. Irrigation shall be highly efficient and appropriate for plant needs. Medium size, narrow and low water using shrubs such as Fortnight Lily *Dietes vegeta*, Dianella, or Dwarf Kangaroo paw *Anigozanthos* shall be incorporated into the parkways to also separate pedestrians from traffic.
- Incorporate King Standard Lighting to match historic lighting.
- Fencing should be decorative and compatible with the historic area.

The Euclid Avenue Median (south of the I-10 and north of Sixth Street):

- The loss and/or removal of existing mature trees should be minimized. Replacement planting shall consist of alternating double rows of California Pepper *Schinus molle*,

Deodar Cedar *Cedrus deodara* or Camphor tree *Cinnamomum camphora*, minimum 48" box size, spaced 30' apart. The existing lawn shall be replaced with a new water efficient grass type. Replace the irrigation components with a new water efficient system appropriate for plant needs.

- Rock curbs should be replaced and/or restored along the median and street edges.
- Incorporate King Standard Lighting to match historic lighting.
- The median width of Euclid Avenue is an important Character-defining Feature and reduction of the width should be minimized.

Additional mitigation measures may include:

- Installation of National Register signs identifying Euclid Avenue located on the median and along I-10.
- Installation of the Euclid Avenue Historic District rock monument sign to match other historic district signs.

Additional comments, concerns, and recommendations related to budget, lane configuration, and onramps for the I-10 Corridor Project thru the City of Ontario will be forwarded to SANBAG and Caltrans.













My apologies for the delay in responding to your request for additional information. Attached are the Draft Area of Potential Effects (APE) maps for this project within the Colton city boundaries. Please note: Caltrans has not reviewed nor approved these maps and they are subject to revision. However, the maps should sufficiently answer your questions. The pink line on the map indicates areas where easements would occur. The easements would result in sliver takes, and it is not anticipated any buildings would require acquisition, relocation, or demolition. The blue lines indicate the approximate location of proposed noisewalls. Areas where potential visual impacts could occur as a result of the construction of the proposed noisewalls were included within the APE. The following I-10 bridges would be reconstructed as a result of this project: Pepper Ave, Slover Mountain UP (over the existing rail line), 6th St, La Cadena, 9th St, and Mt Vernon Ave. The Caltrans historic bridge inventory lists these bridges as Category 5, or "Not eligible for NRHP." The project is being funded with state/federal funds; therefore, the project is subject to both Section 106 of the National Historic Preservation Act and CEQA.







PROJECT LOCATION MAP



Thank you for seeking my consultation regarding the above noted undertaking in accordance with the *Programmatic Agreement (PA) Among the Federal Highway Administration, the Advisory Council on Historic Preservation, the California State Historic Preservation Officer, and the California Department of Transportation Regarding Compliance with Section 106 of the National Historic Preservation Act, as it Pertains to the Administration of the Federal-Aid Highway Program in California*. Pursuant to Stipulation VIII of the PA, the California Department of Transportation (Caltrans) has determined the Area of Potential Effects (APE) and has completed identification and evaluation of historic properties within the APE.

The undertaking consists of raising the east-west Union Pacific rail line by placing it on an elevated structure to span the Burlington Northern Santa Fe tracks. An access road along the structure will also be constructed. The elevated structure will be supported by piles driven to a depth of approximately 100 feet. The structure will be 44 feet in height above ground level, and run approximately 1.5 miles in length. The structure will be approximately 50 feet wide. Most of the structure will be built atop fill contained by six foot retaining walls. The entire APE will run the length of the structure, 2.5 miles, and varies between 40 feet wide for access routes and staging to 350 feet wide at its widest to accommodate staging areas and construction activities.

You are requesting my concurrence, pursuant to Stipulation VIII.C.5 of the PA, on your determination of eligibility, for the National Register of Historic Places (NRHP), of nine historic properties identified within the APE. In addition to your letter of May 9, 2011 (received in my office on May 11, 2011), you have submitted the following documents in support of this undertaking:

- *Historic Property Survey Report for the Colton Crossing Rail to Rail Grade Separation Project, City of Colton, San Bernardino County, California* (Riordan Goodwin, LSA Associates, April 2011)

As documented in the report noted above, Caltrans has identified 16 archaeological sites within the Area of Potential Effects. Of these Caltrans has assumed seven of the sites eligible and will avoid the sites through the establishment of Environmentally Sensitive Areas (ESA). The other nine archaeological sites are all foundational remains and highly disturbed refuse deposits associated with the Colton Railyard. Caltrans has determined all nine of these historic archaeological sites not eligible for the NRHP. The deposits are highly disturbed and are unlikely to yield significant information relating to the history of railroads in the region. Native

American consultation was undertaken with letters sent by Caltrans' consultant May 26, 2010. Of note, the Soboba Band of Luiseno Indians and the Pechanga Band of Mission Indians requested government-to-government consultation and the San Manuel Band of Mission Indians stated they would forward their comments directly to Caltrans. The Morongo Band of Mission Indians and the Serrano Nation of Indians both requested to be informed and for consultation to continue in the event of a discovery, especially in the case of human remains. No further record of consultation was provided by Caltrans, including any applicable follow-up with those tribes that requested government-to-government consultation. Please ensure these requests are fulfilled prior to the initiation of construction.

Based on my review of your letter and supporting documentation, I have the following comments:

- 1) Please be aware, that while you may request expedited review pursuant to 36 CFR 800.3(g), it is the SHPO's prerogative to agree to such a request. Additionally, this section of the regulations discusses collapsing steps 800.3 - 800.6 of the process, shortening the SHPO's time period to comment to within 30-days rather than the allowable 90-days. In the future please consult under a reasonable time frame as I will be reluctant to agree to consultation under such terms in the future.
- 2) I concur that the Southern Pacific Railroad segment, California Southern Railroad Segment, American Railway Express Company, Southern Pacific passenger depot, and South Colton are not eligible for the National Register.
- 3) I concur that all nine sites, P-36-007976, -022625, -022626, -022628, -022179, -022180, -022181, -022182, and -022637 are not eligible for the National Register.
- 4) I concur in the establishment of ESAs to protect sites P-36-022627, -022629, -022630, -022631, -022632, -022633, and -022634.
- 5) I therefore have no objection to Caltrans' finding of No Adverse Effect with Standard Conditions (ESA).

Be advised that under certain circumstances, such as unanticipated discovery or a change in project description, Caltrans may have additional future responsibilities for this undertaking under 36 CFR Part 800.
